

BUSINESS PRIVACY POLICY

GENERAL

Lumen Well Company, LLC ("company" or "we" or "us" or "our") respects the privacy of everyone ("site visitor" "user" or "you") that uses the electronic or physical services of company, weather online or offline, collectively hereafter ("services").

In no event shall any claim, action or proceeding by you related in any way to the operation of company and site be instituted more than a (2) Two-Year Period after the cause of action arose.
